## Firearm Offences



We will pay your legal costs to defend your rights if you are being prosecuted for an offence arising out of self-defence or the use, storage, display, transportation, or handling of a firearm.

### Real Event

Following a noise complaint from a neighbour, the police visited a policyholder's home and discovered a firearm out of its safe. The policyholder was charged with unsafe storage of a firearm. DAS appointed a lawyer to defend the policyholder.

## Firearm Licensing



We will pay your legal costs to represent you in appealing a decision to suspend, revoke, or refuse your firearms licence.

### Real Event

The certification of a firearms training instructor was suspended after a review by the Royal Canadian Mounted Police. The instructor disagreed with the decision and wished to appeal. DAS appointed legal representation to appeal the decision.

Legal Expense Insurance (LEI) covers the legal costs of your disputes. It also fills the gaps in your existing insurance coverage. It provides coverage of up to \$150,000 toward legal expenses per claim. There is a maximum of \$500,000 for all claims per policy period. There is no deductible.
