AFFIDAVIT

- I, Laurence Knowles, of the village of Old Massett in Haida Gwaii, British Columbia, SWEAR (or AFFIRM) THAT:
- I am an Applicant to the Application in Court File No T-577-20 (the "Application"). I am an individual ordinarily resident on the islands of Haida Gwaii in British Columbia. I have personal knowledge of the facts sworn to in this Affidavit, except where I have stated facts that are based on information I have received, and in those cases I believe the information to be true.
- 2. I am a Status Indian under the *Indian Act*, RSC 1985, c I-5. I am a member of the Haida Nation. I have been hunting and safely using firearms on a nearly daily basis for over 40 years.
- 3. The Application is a judicial review application and Charter challenge of the Regulations
 Amending the Regulations Prescribing Certain Firearms and Other Weapons, Components

and Parts of Weapons, Accessories, Cartridge Magazines, Ammunition and Projectiles as Prohibited, Restricted or Non-Restricted, SOR/2020-96 (the "Regulation") and the Order Declaring an Amnesty Period (2020), SOR/2020-97 (the "Amnesty Order"). The Application is also a judicial review application of certain ad hoc things done by the Royal Canadian Mounted Police ("RCMP"), including through the Specialized Firearms Supports Services Unit ("RCMP SFSS") and the Firearms Reference Table ("FRT"), as described in the Application. I adopt the defined terms in that Application for the purposes of this my Affidavit.

Background

- 4. I am 53 years old. I was born in Prince Rupert and reside on the islands of Haida Gwaii, which is the traditional territory of the Haida. Haida Gwaii is approximately 250km north west of Vancouver Island, and 120km west of Prince Rupert. The islands of Haida Gwaii are heavily forested and are mostly wilderness.
- 5. My family moved to Prince Rupert during World War II, when the majority of Haida women and children were relocated to Prince Rupert because of fear of invasion from Japan. I moved back to Haida Gwaii about 25 years ago.
- 6. My family were primarily fishers. I was taught to fish at eight years old and I was a commercial fisherman for much of my life, until government regulation, private commercial fishing and fishing tourism devastated this industry in Haida Gwaii and made it impossible for me and my family to continue fishing.
- 7. Since that time, when employment is necessary for me to earn money, I have primarily worked off-island, as far away as Manitoba. This work involves spending a lot of time far from home, and I do not enjoy that, but it is a necessary part of my life. Aside from off-island work, I do some trapping work, but that is rarely compensated and is usually just for the benefit of the community. I also work as a carver of traditional items, including totem poles.

- 8. Hunting and trapping are part of the traditional way of life of the Haida people. My hunting helps sustain me, my family, and my community by providing food. My hunting and trapping activities take place primarily in the traditional lands of the Haida people.
- 9. I was given my first rifle, a single-shot .22, when I was eight years old, when my uncles first taught me to hunt deer. They told me that "a working man should have a rifle". It is traditional for the Haida to have one's uncles teach you how to be a man, including how to hunt. This practice is based on Haida tradition that the stories tell us stretches back to before the Ice Age.
- 10. I, like many other Haida, prefer to eat "soul food", that is, food that has been hunted or harvested from nature, rather than bought from a store. I find store-bought meat tastes rotten, and I resort to it only when necessary. Also, because Haida Gwaii is so remote, store-bought food -- particularly meat -- is very expensive.
- 11. For food, I hunt deer, seals, sealions, elk, and moose. The reality of hunting as a food source is that it is not a guarantee. If the hunt is unsuccessful, that can mean a choice between going hungry or resorting to unpleasant store-bought food.
- 12. This can be more serious in some years, including right now. For example, in 2020, the salmon run is expected to be poor, and I am aware that the government has already placed some restrictions on harvesting salmon, including in areas very close to Haida Gwaii. For example, attached as Exhibit "A" is a news article discussing restrictions on salmon harvesting for 2020 in the Skeena watershed, in the Prince Rupert area, just to the east of Haida Gwaii. I am advised by my counsel and believe that the Skeena watershed is part of "Area A", as determined by the Department of Fisheries and Oceans, which includes all of Haida Gwaii. Attached as Exhibit "B" is a map showing the extent of Area A.
- 13. As a result of these restrictions and the lack of salmon, my community will need to find sustenance alternatives, which means an increased reliance on sustenance hunting as a source of food. If we cannot replace salmon with sustenance hunting, we will have to resort to unpleasant store-bought food. There are already concerns in my community about food shortages as a result of the price of store-bought food and salmon shortages.

- 14. In addition to sustenance, hunting and trapping have other important functions for the Haida. They are important rituals that connect me with other Haida, my ancestors, and with the land. The Haida use all of the parts of the animal, for food and for traditional clothing, regalia, and artwork. For example, the whiskers of sealions are used for headdresses, the teeth are used for carvings, and the hides are used to make clothing.
- 15. Trapping -- that is, hunting of small game like deer and rodents -- is also not only part of the way of life of the Haida, but is required to preserve the balance of the environment on Haida Gwaii. The populations of raccoons, deer, and rodents have no natural predators on Haida Gwaii. Without trapping and culling, leaving the populations unchecked, these animals can damage the delicate ecosystems and environment of Haida Gwaii, for example:
 - (a) There are a number of shorebird species at risk, which nest on the ground in Haida Gwaii. Their eggs are targeted by raccoons and rats, which further threatens their populations and could lead to their extinction.
 - (b) Beavers, which were introduced to Haida Gwaii by the government of British Columbia, can cause significant problems in the small rivers throughout Haida Gwaii. They create obstructions in these rivers which inhibit the salmon run. Damage to the salmon run is a significant food security issue for the Haida. Aside from logging, beavers are the largest threat to salmon populations.
 - (c) Due to the logging of old-growth forest on Haida Gwaii, cedar trees -- which are used by Haida for carving and building of traditional longhouses -- are replanted by the forestry industry as saplings. Deer eat the saplings and threaten the continued viability of the cedar forests. The depletion of old-growth cedar due to logging and lack of renewal has led to the increasing use of "conventional" housing materials, which are non-traditional to the Haida, and which suffer from mould problems due to the wet climate.
 - (d) Seals and sealions are beginning to be overpopulated. The government has left it to Aboriginals to manage these populations, I believe due to the political sensitivity

of sanctioning seal hunts. Overpopulation of these species further threatens salmon populations, and therefore the Haida's food security.

Restricted Firearms

- 16. I own four rifles which have been newly prescribed under the Regulation as "Prohibited Items": a Stag-10, an ATRS Modern Varmint, and two Polytech M14s (the "Prohibited Rifles").
- 17. Each of the Prohibited Rifles has a particular use in my hunting and trapping activities. These are expensive guns, particularly given that I only work off-island for money occasionally, and they were selected very carefully and deliberately. These are large and significant purchases for me, and they were made with specific purposes in mind. The combined cost of the Prohibited Rifles is more than my truck, or my boat.
- 18. The ATRS Modern Varmint is similar to an AR-15, but was non-restricted (prior to the Regulation). I use it primarily to limit the population of raccoons, small deer and other species. As of June 1, 2020, a new ATRS Modern Varmint costs approximately \$3,350, without accessories. I purchased the ATRS when it first entered production in 2015-16. I was working in Saskatchewan and Alberta around that time. Attached hereto as **Exhibit** "C" is a screenshot from Alberta Tactical Rifle Supply's website, showing the cost of this rifle.
- 19. I bought the Stag-10 from Wolverine Supplies in 2018 in Manitoba, when I was working there. As of June 1, 2020, a new Stag-10 costs approximately \$1,800 without accessories. Attached hereto as Exhibit "D" is a screenshot from Wolverine's website, showing the cost of this rifle.
- 20. The ATRS and the M14s are both good for similar purposes and serve essentially the same function, but the ATRS is, in my opinion, simply a better rifle. I purchased my M14s from Wolverine about 7-8 years ago, for approximately \$800 each.
- 21. Hunting is a precise activity, and there is a very small window for success. It is essential to have proper, specialized, and well-functioning equipment for this reason. Not just any gun

will do for any hunting purpose. This is especially true when hunting from a boat or a canoe. The waves on a boat reduce your accuracy and mean your first shot does not always land, and if you cannot follow that up with a very quick second or third shot, you will lose the prey. If the first shot lands but only wounds the animal, without a quick second shot, the animal may escape but could suffer for a long time before it dies.

- 22. There are a number of factors to consider in selecting the right rifle, including the size of the prey, the likely distance of the shot, whether the shot will take place on land or from a boat, whether a second or third shot is typically necessary, and so on. My decisions to purchase the Prohibited Rifles were based on these factors and the specific needs of the kind of hunting I typically do. I could have bought other guns, but these were the ones best suited to my purposes. The non-prohibited guns I own are inadequate for the purposes for which I use the Prohibited Rifles.
- 23. For example, the ATRS Modern Varmint is particularly well-suited to hunting and trapping from a boat, because of its fast follow-up shot.
- I use the Stag-10 for larger prey, like sealions, elk, and moose. Sealions are large prey and require a "lot of gun". The firearm I have best suited for sealions is the Stag-10. Even my other Prohibited Items are not adequate for hunting sealions. The Stag-10 is also particularly well-suited to elk, as the quick follow-up shots along with the excellent balancing of the rifle allow me to potentially get a second animal. Semiautomatic rifles are irreplaceable when I hope to get more than one animal in a herd. Re-racking a shot in a single-shot or bolt-action rifle is too noisy and too slow for this purpose.
- 25. The M14s are relatively inexpensive semi-automatic rifles which are quite durable, and are well suited to hunting from a boat and on beaches. They are resistant to damage from saltwater, and hunting in boats or on beaches in Haida Gwaii results in a lot of saltwater exposure to firearms.
- 26. A lot of trapping and wildlife management is done from boats or on beaches, and anything in place of the Prohibited Items would be poor substitutes.

- 27. Smaller, single-shot non-prohibited rifles such as .22s are useful to teach young people how to hunt, and for some other limited purposes. I occasionally use a .22 when hunting in deep cover as it is possible to get very close to the prey, and the short range of the .22 is not a problem. However, the effectiveness of a .22 diminishes very quickly after about 30 feet of range, and they are basically useless from 50 feet or more away from the target. At that range, you may not even wound a larger animal, much less kill it. This makes .22s poorly-suited to hunting from a boat, at sea, or on-land where cover is sparse, such as on beaches. While I own a number of .22s which remain unprohibited, they are simply not adequate replacements for the Prohibited Rifles.
- 28. There are additional challenges to hunting on-land in remote areas due to the bear population. Many bears are conditioned to approach the sound of gunshots, as a reliable way to find food. This means on-land hunting requires very quick and efficient killing and dressing of the animals. When a bear approaches after I have made a kill, the presence of food for the bear means I often have to scare it off by firing several warning shots in quick succession. If I am unable to do so, I may lose my prey to the bear or possibly face the serious danger of a confrontation with a bear. A bolt-action rifle is simply not up to this task. In the event of a confrontation, or when the bear is the prey, a powerful semi-automatic rifle is the only way I have to safely and humanely kill the animal. A lesser-powered weapon, or a weapon where there is significant reloading time between shots, will cause unnecessary suffering to the animal and pose a risk to my safety.
- 29. Even assuming I could find suitable non-prohibited replacements for my rifles, it would take me a lot of time and effort to be able to find them and afford them. Buying the rifles would itself require travel far from home, as there is nowhere on Haida Gwaii, or even in Prince Rupert, where I can buy specialized hunting rifles.
- 30. I do work for money only occasionally, as there is little or no work of this kind for me on Haida Gwaii. However, it is a reality of life that work for money will be needed from time to time. The jobs I have experience with require significant and extended travel away from my home and my family, as far away as Manitoba. It was through these work stints that I

- earned the money to purchase my rifles. Each of these purchases meant the sacrifice of extended time away from home.
- In short, I believe there are no suitable, legal replacements for the Prohibited Rifles. Even if there were, I cannot easily afford to replace this specialized equipment. Without using the Prohibited Rifles, I will not be able to hunt in the same way, hunting the same game, in the same area. From my conversations with other Haida, I know this is true for many of them as well.

Learning about the Regulation; No consultation

- 32. I learned about the Regulation on the day it was announced by Prime Minster Trudeau.

 After I heard about it, I logged on to the government's website to check if any of my rifles were going to be prohibited, and learned that all four of the Prohibited Rifles were on the list.
- 33. I am not aware of any communications between the Haida people and the Federal Government about the Regulation, or about restricting or prohibiting of certain kinds of firearms specifically. If there had been any such communication, it would have been discussed in the Haida House of Assembly. There were no discussions like that. Based on that, I do not believe the Haida were consulted about any potential impacts that the Regulation might have on our ability to hunt and trap in the way we traditionally do, and the way in which we prefer.
- 34. I believe that there are a lot of Haida who are in a similar situation to me with their use of items that were prohibited under the Regulation. From my conversations with other Haida, the feeling is that this is another attempt by the government to roll back our rights and infringe on our way of life. We feel like the government is trying to tell us how to hunt, and what equipment to use, when this should be our decision.

Conclusion

35. If I am unable to use my Prohibited Items, this will hurt my ability to provide sustenance for myself, my family, and my community. I believe this is true for many other Haida people as well. It will also hurt my ability to do trapping and other wildlife management.

Those things impact my ability to live in the traditional way of the Haida. Hunting, trapping, and the use of those animals are all traditional ways of life for me and the Haida. These activities, and the way in which we prefer to go about them, connect me with the land, my family, my community, and my ancestors.

36. I swear this Affidavit in support of an Application for an injunction to stay the effect of the Regulation as a result of its infringement of my constitutionally-protected Aboriginal rights.



Salmon closures announced for Skeena and Nass watersheds

DFO notice expands on May 21 chinook ban throughout Skeena watershed

QUINN BENDER / May. 27, 2020 1:30 p.m. / LOCAL NEWS / NEWS

The Department of Fisheries and Oceans has announced widespread closures to recreational salmon fishing affecting all fresh water areas of the North Coast.

The notice, effective May 27, includes a ban on chinook in all lakes and rivers flowing into management areas 3 to 6. The announcement expands on a May 19 notice prohibiting chinook angling throughout the Skeena Watershed.

In an email to Black Press Media a DFO spokesperson said the restrictions are in response to a Skeena Chinook return estimate of just 38,754. It was noted there will be no targeted commercial fisheries on Skeena Chinook this year, and that the final Area F Commercial troll fishery will be timed to avoid the species.

"Overall, expectations for salmon returns are generally low and similar to last year," the spokesperson wrote. "A key factor is the relatively poor conditions for ocean survival for the sea entry and freshwater rearing years for salmon returning in 2020."

Today's notice also reduces the allowable catch of North Coast coho to two, excluding the Kitimat River.

Bans on all salmon species are also now in effect until further notice for sections of the Skeena mainstem near the Kitwanga and Kispiox Rivers. Future prohibitions are planned for July 1 to Aug. 31 near and within the Kitsumkalum River.

Recreational fishing for chum salmon remains closed throughout the Skeena and Nass River watersheds.

A draft of the Integrated Fisheries Management Plan forewarned low Chinook returns will call for conservation measures similar to 2018, which saw widespread closures on all species.

The DFO spokesperson blamed the low numbers primarily on environmental factors, adding that while fisheries plans will be adjusted throughout the season to account for actual returns, further closures are a possibility.

"Given the anticipated ongoing impacts of the extremely warm water temperatures in the central North East Pacific ocean starting in late 2013 and the resulting changes in the marine food web – zooplankton composition, density, and distribution, as well as the potential for drought conditions through the summer and fall (leading to lower than normal flows and higher than normal water temperatures), there will likely be requirements for additional management actions to ensure adequate numbers of certain stocks have the opportunity to migrate up-river and spawn."


Below are diagrams of the 3 stainless barrel contours available:


